That we, the undersigned, citizens and residents of the State of California, do hereby voluntarily associate ourselves together for the purpose of incorporating un-

der the laws of the State of California, and in pursuance of the purposes for which we have been elected, a social corporation, without profit and without capital stock.

AND WE DO HEREBY CERTIFY:

FIRST: That the name of said corporation shall be "EBELL CLUB OF ANAHEIM".

SECOND: That the purposes for which said corporation is formed To Conduct an Ebell Club for women at Anaheim, California; to advance the general study of literature; to encourage artistic culture; to improve civic conditions; and to promote the best interests of the community; and in connection therewith to hold and give lectures and social entertainments; and incidentally thereof to purchase, take, have, or otherwise acquire, own, hold and maintain, real and personal property, for the proper transaction of its business, and when for the best interests of the corporation to sell or otherwise dispose of the same in such manner and form as the corporation may deem proper; to encumber such property, or any part thereof, by mortgage or trust deed and to erect thereon all buildings required by the corporation.

And generally to do and perform every act and thing necessary, suitable, proper or convenient for the accomplishment of any of the purposes or attainment of any of the objects herein enumerated.

THIRD: That the place where the principal business of this corporation is to be transacted shall be the City of Anaheim, Orange is Fifty years from and after the date of its incorporation.

That the number of Directors of said corporation shall FIFTH: be Nine, and the names and residences of the Directors who are elected for the first year, and to serve until the election and qualification of their successors, are as follows, to-wit:

That on Tuesday, January 17th, 1922, at a meeting duly called and noticed for said purpose, and at the regular meeting place of said Ebell Club in the Fisher Building, in the City of Anaheim, Orange County, California, a majority of the members of said Ebell Club were then and there present, and voted, and a resolution was unanimously adopted declaring in favor of the incorporation of said Ebell Club and the election of a Board of Nine Directors; that an election was thereupon held and resulted in the unanimous election of the hereinbefore named Directors, all residents of Anaheim,
